

THREE & FOUR YEAR OLD FUNDING INFORMATION

At Woldingham Nursery Class, we deliver the Foundation Stage curriculum for 38 weeks a year. We are pleased to offer places for 3 & 4 year olds in receipt of Universal Funding and 30 Hour Funding.

You can use the 15/30 hours funding per week flexibly for any of the sessions you wish your child to attend.

For example, your child could attend for 3 hours per day Monday – Friday or you may choose 2 full days, morning (9am – 12pm) and afternoon (12pm – 3pm) and an additional morning session or your child could attend for 5 hours per day for 3 days.

Extra morning or afternoon sessions and additional lunch hour sessions above the 15 hour per week funding remain payable at the standard rates

If your child is eligible for 30 hours Free Funding, the funding will cover all the available sessions each week.

Parents are not required to pay a booking fee for a funded place at the nursery and there are no additional charges for snacks and drinks or any other items.

Funded Early Education for 3 and 4 Year Olds

All three and four year olds living in England are entitled to 570 hours of free early education and childcare a year. This is usually offered as 15 hours a week for up to 38 weeks a year and is a universal entitlement. In addition, the government increased the free hours from 15 to 30 a week for children of working families who meet the eligibility criteria. This means that eligible children are able to receive up to 1140 hours of free childcare a year. These changes were introduced as part of the Childcare Act 2016.

The extra free hours above the universal funding, will be made available to families where both parents (or the sole parent in a lone parent family):

- are working and earn on average a weekly minimum amount equivalent to working 16 hours at either National Minimum Wage (NMW), National Living Wage (NLW) or National Apprentice Rate
- have an income of no more than £100,000 each per year
- live in England

You may still be eligible to apply if you or your partner:

- are taking paid time off work, such as maternity leave, paternity leave or sick leave
- are temporarily away from England for a period of up to 6 months, such as on military duty

You can also apply if either you or your partner are employed or self-employed and one of you gets one of more of the following benefits:

- contribution-based Employment and Support Allowance
- Carer's Allowance
- Incapacity Benefit or long-term Incapacity Benefit
- Severe Disablement Allowance
- National Insurance credits because of incapacity or limited capability for work
- you've been assessed as having limited capability for work for Universal Credit purposes

How Do I Claim?

To claim the 30 free hours of childcare, you must apply through the Childcare Choices Government website: www.childcarechoices.gov.uk

This site will help you to see what childcare support you are entitled to. If you are eligible for the 30 free hours, you will be given an 11-digit code and will be told when you can start to use your funded hours.

Once you have the code, give it to us and we can then help to submit a form to Surrey County Council. It's really important that you check your eligibility as soon as possible as Surrey County Council will not fund children without confirmation of eligibility codes first.

Deadlines

If you wish to start using the 30 hours free childcare you need to apply through www.childcarechoices.gov.uk by the end of the term before you want your funding to begin.

Deadline for:

- Autumn Term (September start date) 31st August
- Spring Term (January start date) 31st December
- Summer Term (April start date) 31st March

Anyone who applies after the deadline will not be able to take up their free extended hours until the following term.
